Federal/Special Education Programs – Dr. Van Deusen shared updates regarding State and Federal programs including Title I & Title II decreases for this year.

Superintendent's Report – Dr. Musser presented a letter from Governor Wolf that expressed gratitude for Cocalico's innovative breakfast program. Ms. Seltzer presented updates on winter sports accomplishments including Boys' Swimming, Bowling, and Wrestling Championships, and congratulated Mr. Fittery for achieving Coach of the Year status. The building principals gave reports as follows: Mrs. Marley on the success of the Iron Chef Cocalico, Mr. Irvine on the high school play, "Godspell", Mr. DiMatteo on the Middle School's MiniThon and play, "To See the Stars", and Mrs. Logue on Adamstown Elementary's Oratory Invitational. Middle School Assistant Principal, Mrs. Snyder, also updated the Board on student accomplishments that included: 7th grader Hailey Stumpo who was a finalist in the Lancaster Newspaper's Spelling Bee and a team of 4 students who took 1st place in a National History Day competition. Lastly, Dr. Haldeman acknowledged that Adamstown Elementary took First Place for Spontaneous in the Odyssey of the Mind Competition and Denver Elementary took Third. Dr. Haldeman also shared that Reamstown Elementary took First Place in the district STEM competition.

General Comments: Mr. Graybill applauded sports achievements and support from administration. Mr. Brenner thanked Mrs. Marley and Mr. Dunn for their 12 years of service in organizing the Iron Chef Cocalico Event.
