Dr. Ella Musser shared the next steps for the approved Health and Safety Plans for Reopening Schools and Athletics. She also reported that workshops have been virtual, however some small teams are now back for in-house workshops and training, and bus training is being conducted onsite. Bringing adults back will help us to guide students when they return. The District may even begin some student tutoring. Dr. Musser advised the Board that updates and communications regarding pandemic protocol are on-going to the staff and parents so that everyone is informed as to what to expect in green, yellow and red phases.

Mr. Graybill thanked the staff for how they have responded during the pandemic and commented that he has heard positive feedback from parents.
